Expenses in 2016 for the PB Equity Fund were 0.74%, compared to an average expense ratio of 1.32% as reported by Morningstar for equity funds with global securities similar to the types of securities in our Fund. Expenses for the Bond Fund were 0.38%, compared to the Morningstar average of 0.80% for similar funds. The Balanced Fund had expenses of 0.63%, compared to the Morningstar average of 1.18% for similar funds. Expenses for the Stable Value Fund in 2016 were 0.57%. Expenses for the TAD 2020, 2025, 2030, 2035, and 2040 Funds were 0.54%, 0.60%, 0.61%, 0.62%, and 0.66%, respectively. Expenses for the GSIF were 0.55%.
